Dear President Biden,

We write to express our deep concerns about human rights in Vietnam ahead of your upcoming visit to the country. Efforts to promote closer ties between the U.S. and Vietnam have coincided with a significant increase in human rights abuses by the Vietnamese state against its own citizens. We strongly urge you to use this visit to address these human rights abuses, and at a minimum, secure the release of prisoners of conscience and extract a guarantee that there will be no further arrests as our relationship with the country is upgraded to a Strategic Partnership.¹

As you know, Vietnam has an abysmal record on human rights, and the crackdown on activism and dissent has continued to intensify in recent years. In this regard, they seem to follow the example of the Chinese Communist Party, with which the Vietnamese Communist Party retains significant party-to-party ties.

Under the crackdown on civil society, scores of dissenters and human rights activists have been imprisoned on vaguely-worded national security or defamation charges. Secretary of State's International Women of Courage Award winner Pham Doan Trang, for example, is currently serving a nine-year prison sentence for "spreading propaganda against the state." The leading human rights organization monitoring the country estimates that Vietnam now has close to 200 prisoners of conscience.² This figure, however, masks the number of people who have been persecuted into silence or forced into exile. A list of confirmed prisoners of conscience is enclosed—we urge you to use this document in your engagements with Vietnamese officials calling for the release of these prisoners.

Many of the prisoners of conscience in Vietnam have been dealt overly harsh sentences after trials that lack any semblance of due process, and some have been imprisoned more than once. One such example is Nguyen Bac Truyen, a Hoa Hao Buddhist, and religious freedom advocate who is currently serving an eleven-year sentence for "carrying out activities aimed at overthrowing the people's administration." Truyen founded the Vietnamese Political and Religious Prisoners Friendship Association, which aims to assist other prisoners of conscience and their families. He was first arrested on November 17, 2006, and sentenced to 3 years and 6 months in prison under Article 88 (1999 Code) on charges of "conducting propaganda" against the Socialist Republic of Vietnam. He was released in May 2010. After his second arrest in 2017,

Truyen was denied access to legal counsel, visits from family, and deliveries of food and medicine, and he was eventually sentenced following a trial that only lasted <u>one day</u>.

Over the past two years, Vietnam's one-party state has imprisoned key leaders of the country's climate change movement on false charges of tax evasion. Hoang Thi Minh Hong, arrested on June 1, is the fifth climate activist charged with tax evasion.³ Hong is an Obama Foundation Scholar who, along with her colleagues, successfully advocated for the government to commit to a policy of net zero carbon emissions by 2050. A human rights investigation published in April documents clear evidence that these prosecutions are politically driven and designed to criminalize policy activism.⁴ The failure to sanction Vietnam for this lawless behavior has had a chilling effect. State authorities are, in effect, taxing US aid and using the threat of criminal prosecution for "tax evasion" as a cudgel to suppress the emergence of an independent civil society, while restricting basic rights to freedom of association and speech.

The arrests of climate change activists are reminiscent of the government's suppression of protesters and bloggers who spoke out after the 2016 Formosa oil spill, the worst environmental disaster in the country's history. Several bloggers and activists were arrested in response to a series of demonstrations taking place throughout the country in 2016, including former Radio Free Asia journalist Nguyen Van Hoa who is serving a seven year prison sentence for his reporting and activism regarding the incident.

Recently, the government's repression has taken on a transnational dimension. In April 2023, on the same day that U.S. Secretary of State Blinken hailed the strength of the U.S.-Vietnam relationship, Vietnamese agents abducted a prominent blogger off the streets of Bangkok and forcibly returned him to Vietnam.⁵ Regrettably, the muted response from the White House and State Department to intensified repression in the country over the past few years, appears to have emboldened hardliners in the communist party. As one human rights activist recently noted, "Hanoi has learned that it can imprison the country's … civil society leaders and face no consequences."⁶ In 2021, US Ambassador to Vietnam Marc Knapper told a nomination hearing of the US Senate Committee on Foreign Relations that if nominated, "I will press the Government of Vietnam to respect the freedoms of expression, association, peaceful assembly, and religion or belief."⁷ He added that "only when we see significant progress on human rights

can our partnership reach its fullest potential." We urge you to strongly weigh the lack of progress on human rights as you consider upgrading our relationship with Vietnam.

We urge you to pursue the following commitments, in your negotiations with Vietnamese state and party leaders:

- Unconditional release of prisoners of conscience;
- Guarantee of a moratorium on arrests of human rights activists; and
- Amnesty for all prisoners of conscience before any arms sales are made to Vietnam.⁸

The upcoming visit to Vietnam presents an opportunity to push for meaningful improvements in the situation for human rights within Vietnam. Thank you for your consideration, and we look forward to continuing to engage on this with your Administration.

- Art. 330. Resisting persons in the performance of their official duties

Art. 331. Abusing democratic freedoms to infringe upon the interests of the State, the legitimate rights and interests of organizations and/or citizens.
